Condos have fully equipped kitchens, fireplace, free Wi-Fi, full scale arcade, outdoor heated swimming pool, & exterior hot-tubs.

Beginner & novice skiers & riders will receive a compulsory skill improvement session the first day of the trip.

The lift ticket will be valid from 9:00 am to 4:00 pm on Monday at Mont Sainte-Anne, 8:30 am to 4:00 pm on Tuesday at Le Massif, and 8:30 am to departure time at Mont Sainte-Anne on Wednesday.

All students must wear helmets while skiing and riding.
